Pre-Registration & Set Format Schedule: Executive Board agreed to establish a pre-arranged tournament schedule for the Thursday weekly tournaments. Sign-ups for the weekly tournament would be done before 5:00 PM on Tuesdays. You can sign up in the locker room or email either Janice White or Mary Crawford. Latecomers will be placed in any vacancies or put in final group. Day of cancellations should be called into the pro shop.
